- "The practice over here is not to just charge the client but also to deliver justice at the same time"







# For the future (Survey data)

#### What I will take home

- Academic writing/skills
- Concepts and perspectives
- Democratic principles
- Teaching and research practices
- And:
  - "The way of teaching here, where the lecturers do not treat us as merely students but as adults who will be going into the working field and training us to prepare for anything that may come in the outside world"
  - "values and soft skills such as patience, empathy, emotional intelligence, tenacity and dedication"

#### What the UK can learn from my country

- Avoid discrimination against non-home students
- Connections between law and nature, medicine, religion
- How to be more concise
- Knowledge of law and procedure in my country
- Work ethic
- And:
  - "A lot can be lost in the round about descriptiveness of the English mind"
  - "It is more organised. Nearly everything is more organised in Austria and Germany..."



## **US criteria mirrored in England and Wales?**

- Networking
- Specialist understanding that is underdeveloped at home
- New forms of reasoning and pedagogy
- Employability (the halo)
- cultural and social experience
